Appendix 1 - Online harms and risks - curriculum coverage



Statement of intent

<u>St Michael's</u> understands that using online services is an important aspect of raising educational standards, promoting pupil achievement and enhancing teaching and learning.

The use of online services is embedded throughout St Michael's; therefore, there are a number of controls in place to ensure the safety of pupils and staff. Online services have been essential and will continue to be essential for delivering home learning.

The breadth of issues classified within online safety is considerable, but they can be categorised into three areas of risk:

- **Content**: Being exposed to illegal, inappropriate or harmful material, e.g. pornography, fake news, and racist or radical and extremist views.
- **Contact**: Being subjected to harmful online interaction with other users, e.g. commercial advertising and adults posing as children or young adults.
- **Conduct**: Personal online behaviour that increases the likelihood of, or causes, harm, e.g. sending and receiving explicit messages, and cyberbullying.

The measures implemented to protect pupils and staff revolve around these areas of risk. Our school has created this policy with the aim of ensuring appropriate and safe use of the internet and other digital technology devices by all pupils and staff.

1. [Updated] Legal framework

- 1.1. This policy has due regard to all relevant legislation and guidance including, but not limited to, the following:

2. [Updated] Roles and responsibilities

2.1. [Updated] The governing board of St Michael's is responsible for:

- Ensuring that this policy is effective and complies with relevant laws and statutory guidance.
- Ensuring Nicola Birch (Designated Safeguarding Lead) remit covers online safety.
- Reviewing this policy on an <u>annual</u> basis.
- Ensuring their own knowledge of online safety issues is up-to-date.
- Ensuring all staff undergo safeguarding and child protection training, including online safety, at induction.
- Ensuring that there are appropriate filtering and monitoring systems in place.
- [New] Ensuring that all relevant school policies have an effective approach to planning for, and responding to, online challenges and hoaxes embedded within them.

2.2. Alyson Rigby is responsible for:

- Supporting Nicola Birch (DSL) and any deputies by ensuring they have enough time and resources to carry out their responsibilities in relation to online safety.
- Ensuring staff receive regular, up-to-date and appropriate online safety training and information as part of their induction and safeguarding training.
- Ensuring online safety practices are audited and evaluated.
- Supporting staff to ensure that online safety is embedded throughout the curriculum so that all pupils can develop an appropriate understanding of online safety.
- Organising engagement with parents to keep them up-to-date with current online safety issues and how St Michael's is keeping pupils safe.
- Working with Nicola Birch (DSL) and MGL and Tom Ferry to conduct halftermly light-touch reviews of this policy.
- Working with Nicola Birch (DSL) and governing board to update this policy on an annual basis.

2.3. Nicola Birch (DSL) is responsible for:

- Taking the lead responsibility for online safety in St Michael's Supporting Tom Ferry in delivering eCadets.
- Acting as the named point of contact within St Michael's on all online safeguarding issues - These will all be made through CPOMS system.
- Undertaking training so they understand the risks associated with online safety and can recognise additional risks that pupils with SEND face online.
- Liaising with relevant members of staff on online safety matters, e.g. Michelle Higgins, MGL and Tom Ferry.
- Ensuring online safety is recognised as part of St Michael's's safeguarding responsibilities and that a coordinated approach is implemented.



- Ensuring safeguarding is considered in St Michael's's approach to remote learning.
- Ensuring appropriate referrals are made to external agencies, as required.
- Keeping up-to-date with current research, legislation and online trends.
- Working with **Tom Ferry** in coordinating St Michael's's participation in local and national online safety events, e.g. Safer Internet Day.
- Establishing a procedure for reporting online safety incidents and inappropriate internet use, both by pupils and staff. (CPOMS)
- Ensuring all members of St Michael's community understand the reporting procedure. (CPOMS Training)
- Maintaining records of reported online safety concerns as well as the actions taken in response to concerns.
- Monitoring online safety incidents to identify trends and any gaps in St Michael's's provision, and using this data to update St Michael's's procedures.
- Reporting to the governing board about online safety on a termly basis.
- Working with Alyson Rigby and MGL and Tom Ferry to conduct half-termly light-touch reviews of this policy.
- Working with Alyson Rigby and governing board to update this policy on an annual basis.

2.4. MGL are responsible for:

- Providing technical support in the development and implementation of St Michael's's online safety policies and procedures.
- Implementing appropriate security measures as directed by Alyson Rigby.
- Ensuring that St Michael's's filtering and monitoring systems are updated as appropriate.
- Working with Nicola Birch (DSL) and <u>Alyson Rigby</u> to conduct <u>half-termly</u> light-touch reviews of this policy.
- Maintaining Fresh Desk.

2.5. All staff members are responsible for:

- Taking responsibility for the security of ICT systems and electronic data they
 use or have access to.
- Modelling good online behaviours.
- Maintaining a professional level of conduct in their personal use of technology.
- Having an awareness of online safety issues.
- Reporting concerns in line with St Michael's's reporting procedure. (CPOMS)
- Where relevant to their role, ensuring online safety is embedded in their teaching of the curriculum.

2.6. Pupils are responsible for:

- Adhering to this policy, the <u>Acceptable Use Agreement (Child Friendly)</u> and other relevant policies.
- Seeking help from school staff if they are concerned about something they or a peer have experienced online.



Reporting online safety incidents and concerns in line with the procedures within this policy.

3. [Updated] The curriculum

3.1. Online safety is embedded throughout the curriculum; however, it is particularly addressed in the following subjects:

- RSE
- Health education
- PSHE
- Citizenship
- Computing
- Come & See
- No Outsiders
- 3.2. The curriculum and St Michael's's approach to online safety is developed in line with the UK Council for Child Internet Safety's 'Education for a Connected World' framework and the DfE's 'Teaching online safety in school' guidance.
- 3.3. Pupils are taught the underpinning knowledge and behaviours that can help them to navigate the online world safely and confidently regardless of the device, platform or app they are using.
- 3.4. Online safety teaching is always appropriate to pupils' ages and developmental stages.
- 3.5. **[Updated]** The underpinning knowledge and behaviours pupils learn through the curriculum include the following:
 - How to evaluate what they see online
 - How to recognise techniques used for persuasion
 - Acceptable and unacceptable online behaviour
 - How to identify online risks
 - How and when to seek support
 - [New] How to identify when something is deliberately deceitful or harmful
 - [New] How to recognise when something they are being asked to do puts them at risk or is age-inappropriate
- 3.6. The online risks pupils may face online are always considered when developing the curriculum. The risks that are considered and how they are covered in the curriculum can be found in Appendix 1 of this policy.
- 3.7. Nicola Birch (DSL) is involved with the development of St Michael's's online safety curriculum which is based around the Knowsley Scheme of work and the eCadets esafety scheme.
- 3.8. St Michael's recognises that, while any pupil can be vulnerable online, there are some pupils who may be more susceptible to online harm or have less support from family and friends in staying safe online, e.g. pupils with SEND and LAC. Relevant



- members of staff, e.g. Michelle Higgins for SEND and Nicola Birch for LAC, work together to ensure the curriculum is tailored so these pupils receive the information and support they need.
- 3.9. Class teachers review external resources prior to using them for the online safety curriculum, to ensure they are appropriate for the cohort of pupils. When reviewing these resources, the following questions are asked:
 - Where does this organisation get their information from?
 - · What is their evidence base?
 - Have they been externally quality assured?
 - What is their background?
 - Are they age appropriate for pupils?
 - Are they appropriate for pupils' developmental stage?
- 3.10. External visitors may be invited into school to help with the delivery of certain aspects of the online safety curriculum. Alyson Rigby and Nicola Birch decide when it is appropriate to invite external groups into school and ensure the visitors selected are appropriate.
- 3.11. Before conducting a lesson or activity on online safety, the class teacher and DSL consider the topic that is being covered and the potential that pupils in the class have suffered or may be suffering from online abuse or harm in this way. Nicola Birch (DSL) advises the staff member on how to best support any pupil who may be especially impacted by a lesson or activity.
- 3.12. Lessons and activities are planned carefully so they do not draw attention to a pupil who is being or has been abused or harmed online, to avoid publicising the abuse.
- 3.13. During an online safety lesson or activity, the class teacher ensures a safe environment is maintained in which pupils feel comfortable to say what they feel and asking questions, and are not worried about getting into trouble or being judged.
- 3.14. If a staff member is concerned about anything pupils raise during online safety lessons and activities, they will make a report in line with sections 16 and 17 of this policy.
- 3.15. If a pupil makes a disclosure to a member of staff regarding online abuse following a lesson or activity, the staff member will follow the reporting procedure outlined in sections 16 and 17 of this policy. (CPOMS)

4. Staff training

- 4.1. All staff receive safeguarding and child protection training, which includes online safety training, during their induction.
- 4.2. Online safety training for staff is updated <u>annually</u> and is delivered in line with advice from the three local safeguarding partners.
- 4.3. In addition to this training, staff also receive regular online safety updates as required and at least annually.
- 4.4. Nicola Birch (DSL) and any deputies undergo training to provide them with the knowledge and skills they need to carry out their role, this includes online safety training. This training is updated at least every two years.



- 4.5. In addition to this formal training, Nicola Birch (DSL) and any deputies receive regular online safety updates to allow them to keep up with any developments relevant to their role. In relation to online safety, these updates allow Nicola Birch (DSL) and their deputies to:
 - Understand the unique risks associated with online safety and be confident that they have the relevant knowledge and capability required to keep pupils safe while they are online at school.
 - Recognise the additional risks that pupils with SEND face online and offer them support to stay safe online.
- 4.6. All staff receive a copy of this policy upon their induction and are informed of any changes to the policy.
- 4.7. Staff are required to adhere to the <u>Staff Code of Conduct</u> at all times, which includes provisions for the acceptable use of technologies and the use of social media.
- 4.8. All staff are informed about how to report online safety concerns, in line with sections 16 and 17 of this policy.
- 4.9. Nicola Birch (DSL) acts as the first point of contact for staff requiring advice about online safety.

5. [Updated] Educating parents

- 5.1. St Michael's works in partnership with parents to ensure pupils stay safe online at school and at home.
- 5.2. Parents are provided with information about St Michael's's approach to online safety and their role in protecting their children.
- 5.3. Parents are sent a copy of the <u>Acceptable Use Agreement</u> at <u>the beginning of each academic year</u> and are encouraged to go through this with their child to ensure their child understands the document and the implications of not following it.
- 5.4. **[New]** Parents will be made aware of the various ways in which their children may be at risk online, including, but not limited to:
 - Child sexual abuse, including grooming.
 - Exposure to radicalising content.
 - Sharing of indecent imagery of pupils, e.g. sexting.
 - Cyberbullying
 - Exposure to age-inappropriate content, e.g. pornography.
 - Exposure to harmful content, e.g. content that encourages self-destructive behaviour.
- 5.5. **[New]** Parents will be informed of the ways in which they can prevent their child from accessing harmful content at home, e.g. by implementing parental controls to block age-inappropriate content.
- 5.6. Parental awareness regarding how they can support their children to be safe online is raised in the following ways:



- Parents' evenings
- Twilight training sessions
- Newsletters
- Online resources

6. Classroom use

- 6.1. A wide range of technology is used during lessons, including the following:
 - Computers
 - Laptops
 - Tablets (iPads, Linx)
 - Intranet
 - Google Apps Classroom, Docs, Slides etc.
 - Cameras
- 6.2. Prior to using any websites, tools, apps or other online platforms in the classroom, or recommending that pupils use these platforms at home, the class teacher always reviews and evaluates the resource.
- 6.3. Class teachers ensure that any internet-derived materials are used in line with copyright law.
- 6.4. Pupils are supervised when using online materials during lesson time this supervision is suitable to their age and ability.

7. Internet access

- 7.1. Pupils, staff and other members of St Michael's community are only granted access to St Michael's's internet network once they have read and signed the Acceptable Use Agreement.
- 7.2. A record is kept of users who have been granted internet access in St Michael's office.
- 7.3. When using school equipment, all members of St Michael's community are required to use St Michael's's internet network, instead of any 3G, 4G and 5G networks, as the network has appropriate filtering and monitoring to ensure individuals are using the internet appropriately. Only when using private devices is private network use permitted within the building. This should not be during teaching time.

8. Filtering and monitoring online activity

- 8.1. The <u>governing board</u> ensures St Michael's's ICT network has appropriate filters and monitoring systems in place. (Smoothwall).
- 8.2. Alyson Rigby and MGL and Tom Ferry undertake a risk assessment to determine what filtering and monitoring systems are required.
- 8.3. The filtering and monitoring systems St Michael's implements are appropriate to pupils' ages, the number of pupils using the network, how often pupils access the network, and the proportionality of costs compared to the risks.



- 8.4. The <u>governing board</u> ensures 'over blocking' does not lead to unreasonable restrictions as to what pupils can be taught with regards to online teaching and safeguarding.
- 8.5. MGL undertake monthly checks on the filtering and monitoring systems to ensure they are effective and appropriate.
- 8.6. Requests regarding making changes to the filtering system are directed to Alyson Rigby.
- 8.7. Prior to making any changes to the filtering system, <u>MGL and Tom Ferry</u> and <u>Nicola Birch</u> (DSL) conduct a risk assessment.
- 8.8. Any changes made to the system are recorded by MGL and Tom Ferry.
- 8.9. Reports of inappropriate websites or materials are made to an <u>ICT technician</u> immediately, who investigates the matter and makes any necessary changes.
- 8.10. Deliberate breaches of the filtering system are reported to Nicola Birch (DSL) and MGL and Tom Ferry, who will escalate the matter appropriately.
- 8.11. If a pupil has deliberately breached the filtering system, they will be disciplined in line with the **Behavioural Policy**.
- 8.12. If a member of staff has deliberately breached the filtering system, they will be disciplined in line with the **Disciplinary Policy and Procedure**.
- 8.13. If material that is believed to be illegal is accessed, inadvertently or deliberately, this material will be reported to the appropriate agency immediately, e.g. the Internet Watch Foundation (IWF), CEOP and/or the police.
- 8.14. St Michael's's network and school-owned devices are appropriately monitored.
- 8.15. All users of the network and school-owned devices are informed about how and why they are monitored.
- 8.16. Concerns identified through monitoring are reported to Nicola Birch (DSL) who manages the situation in line with sections 16 and 17 of this policy.
- 8.17. Extra provisions to be looked into to bolster existing filtering systems like Impero.

9. Network security

- 9.1. Technical security features, such as anti-virus software, are kept up-to-date and managed by MGL
- 9.2. Firewalls are switched on at all times.
- 9.3. MGL review the firewalls on a weekly basis to ensure they are running correctly, and to carry out any required updates.
- 9.4. Staff and pupils are advised not to download unapproved software or open unfamiliar email attachments.
- 9.5. Staff members and pupils report all malware and virus attacks to MGL and Tom Ferry.



- 9.6. All members of staff have their own unique usernames and private passwords to access St Michael's's systems.
- 9.7. Pupils in <u>class year or key stage</u> and above are provided with their own unique username and private passwords for Google Accounts on iPads and Chromebooks.
- 9.8. Children to use Year Group Log Ins for laptops.
- 9.9. Staff members and pupils are responsible for keeping their passwords private.
- 9.10. Passwords have a minimum and maximum length and require a mixture of letters, numbers and symbols to ensure they are as secure as possible.
- 9.11. Users are not permitted to share their login details with others and are not allowed to log in as another user at any time.
- 9.12. Users are required to lock access to devices and systems when they are not in use.
- 9.13. Users inform MGL and Tom Ferry if they forget their login details, who will arrange for the user to access the systems under different login details.
- 9.14. If a user is found to be sharing their login details or otherwise mistreating the password system, Alyson Rigby is informed and decides the necessary action to take.
- 9.15. Full details of St Michael's's network security measures can be found in the <u>Data and E-Security Breach Prevention and Management Plan</u>.

10. Emails

- 10.1. Access to and the use of emails is managed in line with the <u>Data Protection Policy</u>, <u>Acceptable Use Agreement</u> and <u>Confidentiality Policy</u>.
- 10.2. Staff and pupils are given approved school email accounts and are only able to use these accounts at school and when doing school-related work outside of school hours.
- 10.3. Prior to being authorised to use the email system, staff and pupils must agree to and sign the Acceptable Use Agreement.
- 10.4. Personal email accounts are not permitted to be used on St Michael's site.
- 10.5. Any email that contains sensitive or personal information is only sent using secure and encrypted email.
- 10.6. Staff members and pupils are required to block spam and junk mail, and report the matter to MGL and Tom Ferry.
- 10.7. St Michael's's monitoring system can detect inappropriate links, malware and profanity within emails staff and pupils are made aware of this.
- 10.8. Chain letters, spam and all other emails from unknown sources are deleted without being opened.
- 10.9. MGL and Tom Ferry organise an annual assembly where they explain what a phishing email and other malicious emails might look like this assembly includes information on the following:



- How to determine whether an email address is legitimate
- The types of address a phishing email could use
- The importance of asking "does the email urge you to act immediately?"
- The importance of checking the spelling and grammar of an email
- 10.10.Any cyberattacks initiated through emails are managed in line with the <u>Data and E-Security Breach Prevention and Management Plan</u>.

11. Social networking

Personal use

- 11.1. Access to social networking sites is filtered as appropriate.
- 11.2. Staff and pupils are not permitted to use social media for personal use during lesson time.
- 11.3. Staff can use personal social media during break and lunchtimes.
- 11.4. Staff members are advised that their conduct on social media can have an impact on their role and reputation within St Michael's.
- 11.5. Staff receive <u>annual</u> training on how to use social media safely and responsibly.
- 11.6. Staff are not permitted to communicate with pupils or parents over social networking sites and are reminded to alter their privacy settings to ensure pupils and parents are not able to contact them on social media.
- 11.7. [New] Where staff have an existing personal relationship with a parent or pupil, and thus are connected with them on social media, e.g. they are close family friends with a parent at St Michael's, they will disclose this to Nicola Birch (DSL) and Alyson Rigby and will ensure that their social media conduct relating to that parent is appropriate for their position in St Michael's.
- 11.8. Pupils are taught how to use social media safely and responsibly through the online safety curriculum Children at St Michael's are too young to access social media sites and promoting this within school is a priority.
- 11.9. Concerns regarding the online conduct of any member of St Michael's community on social media are reported to Nicola Birch (DSL) and managed in accordance with the relevant policy, e.g. <u>Anti-Bullying Policy</u>, <u>Staff Code of Conduct</u> and <u>Behavioural Policy</u>.

Use on behalf of St Michael's

- 11.10.The use of social media on behalf of St Michael's is conducted in line with the Social Media Policy. (Class and school Twitter pages)
- 11.11.St Michael's's official social media channels are only used for official educational or engagement purposes.
- 11.12.Staff members must be authorised by Alyson Rigby to access to St Michael's's social media accounts. (Twitter & Youtube)
- 11.13.All communication on official social media channels by staff on behalf of St Michael's is clear, transparent and open to scrutiny.



- 11.14.Staff must not send private messages on Twitter or YouTube. All correspondence should be made via year group email accounts or over the phone or in person.
- 11.15.The <u>Staff Code of Conduct</u> contains information on the acceptable use of social media staff members are required to follow these expectations at all times.

12.[New] Online hoaxes and harmful online challenges

- 12.1.For the purposes of this policy, an "online hoax" is defined as a deliberate lie designed to seem truthful, normally one that is intended to scaremonger or to distress individuals who come across it, spread on online social media platforms.
- 12.2.For the purposes of this policy, "harmful online challenges" refers to challenges that are targeted at young people and generally involve users recording themselves participating in an online challenge, distributing the video through social media channels and daring others to do the same. Although many online challenges are harmless, an online challenge becomes harmful when it could potentially put the participant at risk of harm, either directly as a result of partaking in the challenge itself or indirectly as a result of the distribution of the video online the latter will usually depend on the age of the pupil and the way in which they are depicted in the video.
- 12.3. Nicola Birch (DSL) ensures that pupils are taught about how to critically identify when online content is untrue or harmful and how to respond to this content, in line with section 3 of this policy.
- 12.4. Nicola Birch (DSL) will work with Michelle Higgins to assess whether some pupils, e.g. pupils who have been identified as being vulnerable or pupils with SEND, need additional help with identifying harmful online challenges and hoaxes, and tailor support accordingly.
- 12.5.St Michael's will ensure all pupils are aware of who to report concerns to surrounding potentially harmful online challenges or hoaxes, e.g. by displaying posters.
- 12.6. Where staff suspect there may be a harmful online challenge or online hoax circulating amongst pupils in St Michael's, they will report this to Nicola Birch (DSL) immediately.
- 12.7. Nicola Birch (DSL) will conduct a case-by-case assessment for any harmful online content brought to their attention, establishing the scale and nature of the possible risk to pupils, and whether the risk is one that is localised to St Michael's or the local area, or whether it extends more widely across the country.
- 12.8. Where the harmful content is prevalent mainly in the local area, Nicola Birch (DSL) will consult with the LA about whether quick local action can prevent the hoax or challenge from spreading more widely.
- 12.9. Nicola Birch (DSL) will check the factual basis of harmful online challenges or hoaxes against a known, reliable and trustworthy source, e.g. the UK Safer Internet Centre, and will carefully consider if a challenge or story is a hoax or is harmful prior to providing any direct warnings to pupils or parents.
- 12.10.St Michael's understands that discussing or naming a specific online hoax can, in some cases, needlessly increase pupils' exposure to distressing content, and will avoid showing pupils distressing content where doing so is not considered absolutely necessary for preventing its spread or easing fears amongst St Michael's community.



- 12.11.Where Nicola Birch's assessment finds an online challenge to be putting pupils at risk of harm, e.g. it encourages children to participate in age-inappropriate activities that could increase safeguarding risks or become a child protection concern, they will ensure that the challenge is directly addressed to the relevant pupils, e.g. those within a particular age range that is directly affected or even to individual children at risk where appropriate.
- 12.12.Nicola Birch (DSL) and Alyson Rigby will only implement a school-wide approach to highlighting potential harms of a hoax or challenge when the risk of needlessly increasing pupils' exposure to the risk is considered and mitigated as far as possible.
- 12.13. Prior to deciding how to respond to a harmful online challenge or hoax, Nicola Birch (DSL) and Alyson Rigby will decide whether each proposed response is:
 - Factual and avoids needlessly scaring or distressing pupils.
 - Not inadvertently encouraging pupils to view the hoax or challenge where they
 would not have otherwise come across it, e.g. where content is explained to
 younger pupils that is almost exclusively being shared amongst older pupils.
 - Proportional to the actual or perceived risk.
 - Helpful to the pupils who are, or are perceived to be, at risk.
 - Age-appropriate and appropriate for the relevant pupils' developmental stage.
 - Supportive.
 - In line with <u>section 16</u> and <u>section 17</u> of this policy.

13.St Michael's website

- 13.1. Alyson Rigby is responsible for the overall content of St Michael's website they will ensure the content is appropriate, accurate, up-to-date and meets government requirements.
- 13.2. Staff are responsible for the content that is posted on their class page and curriculum page (if they are subject leaders).
- 13.3. The website complies with guidelines for publications including accessibility, data protection, respect for intellectual property rights, privacy policies and copyright law.
- 13.4. Personal information relating to staff and pupils is not published on the website.
- 13.5. Images and videos are only posted on the website if the provisions in the Photography Policy are met.

14.Use of school-owned devices

- 14.1. Staff members can be issued with the following devices to assist with their work:
 - Laptop
 - Tablet
 - Computer
 - Mobile Phone



- 14.2. Pupils are provided with school-owned devices as necessary to assist in the delivery of the curriculum, e.g. tablets to use during lessons.
- 14.3. School-owned devices are used in accordance with the Device User Agreement.
- 14.4. Staff and pupils are not permitted to connect school-owned devices to public Wi-Fi networks.
- 14.5. All school-owned devices are password protected.
- 14.6. All mobile school-owned devices are fitted with tracking software to ensure they can be retrieved if lost or stolen.
- 14.7. All school-owned devices are fitted with software to ensure they can be remotely accessed, in case data on the device needs to be protected, retrieved or erased.
- 14.8. MGL and Tom Ferry review all school-owned devices on a monthly basis to carry out software updates and ensure there is no inappropriate material or malware on the devices.
- 14.9. No software, apps or other programmes can be downloaded onto a device without authorisation from MGL and Tom Ferry.
- 14.10.Cases of staff members or pupils found to be misusing school-owned devices will be managed in line with the <u>Disciplinary Policy and Procedure</u> and <u>Behavioural Policy</u> respectively.

15.[Updated] Use of personal devices

- 15.1. It is strongly recommend that no personal devices are to be used on the school network. Any personal devices that are to be used must be authorised by Alyson Rigby. These devices must then follow the following:
- 15.2. Personal devices are to be used in accordance with the <u>St Michael's Acceptable Policy</u>.
- 15.3. Any personal electronic device that is brought into school is the responsibility of the staff member.
- 15.4. Personal devices are not permitted to be used in the following locations:
 - Toilets
 - Changing rooms
 - Classrooms
 - Corridors
 - Playground
- 15.4. Staff members are not permitted to use their personal devices during lesson time, other than in an emergency.
- 15.5. Staff members are not permitted to use their personal devices to take photos or videos of pupils.
- 15.6. Staff members report concerns about their colleagues' use of personal devices on St Michael's premises in line with the <u>Allegations of Abuse Against Staff Policy</u>.



- 15.7. If a member of staff is thought to have illegal content saved or stored on a personal device, or to have committed an offence using a personal device, Alyson Rigby will inform the police and action will be taken in line with the Allegations of Abuse Against Staff Policy.
- 15.8. Pupils are not permitted to bring in personal devices apart from the following situations:
 - Year Six pupil who walks home may bring in their mobile phone for use after school.
- 15.9. Pupils who bring their personal devices in should be stored in the school office with Miss Lafferty.
- 15.10.If a pupil needs to contact their parents during St Michael's day, staff can contact them on behalf of the child in certain situations. Staff will use the phone in St Michael's office.
- 15.11. Alyson Rigby may authorise the use of mobile devices by a pupil for safety or precautionary use.
- 15.12. Pupils' devices can be searched, screened and confiscated in accordance with the **Searching, Screening and Confiscation Policy**.
- 15.13.If a staff member reasonably believes a pupil's personal device has been used to commit an offence or may provide evidence relating to an offence, the device will be handed to the police.
- 15.14. Appropriate signage is displayed to inform visitors to St Michael's of the expected use of personal devices.
- 15.15. Any concerns about visitors' use of personal devices on St Michael's premises are reported to Nicola Birch (DSL).

16.[Updated] Managing reports of online safety incidents

- 16.1. Staff members and pupils are informed about what constitutes inappropriate online behaviour in the following ways:
 - Staff training
 - The online safety curriculum
 - Assemblies
 - Online training
 - eCadets sessions
- 16.2. Concerns regarding a staff member's online behaviour are reported to Alyson Rigby who decides on the best course of action in line with the relevant policies, e.g. Staff Code of Conduct, Allegations of Abuse Against Staff Policy and Disciplinary Policy and Procedures.
- 16.3. Concerns regarding a pupil's online behaviour are reported to Nicola Birch (DSL) who investigates concerns with relevant staff members, e.g. <u>Alyson Rigby</u> and <u>MGL</u> and <u>Tom Ferry</u>.
- 16.4. Concerns regarding a pupil's online behaviour are dealt with in accordance with relevant policies depending on their nature, e.g. <u>Behavioural Policy</u> and <u>Child</u> <u>Protection and Safeguarding Policy</u>.



- 16.5. Where there is a concern that illegal activity has taken place, Alyson Rigby contacts the police.
- 16.6. [New] St Michael's avoids unnecessarily criminalising pupils, e.g. calling the police, where criminal behaviour is thought to be inadvertent and as a result of ignorance or normal developmental curiosity, e.g. a pupil has taken and distributed indecent imagery of themselves. Nicola Birch (DSL) will decide in which cases this response is appropriate and will manage such cases in line with the Child Protection and Safeguarding Policy.
- 16.7. All online safety incidents and St Michael's's response are recorded by Nicola Birch (DSL).
- 16.8. <u>Section 17</u> of this policy outlines how St Michael's responds to specific online safety concerns, such as cyberbullying and peer-on-peer abuse.

17.[Updated] Responding to specific online safety concerns

Cyberbullying

- 17.1. Cyberbullying, against both pupils and staff, is not tolerated.
- 17.2. Any incidents of cyberbullying are dealt with quickly and effectively whenever they occur.
- 17.3. Information about St Michael's's full response to incidents of cyberbullying can be found in the Cyberbullying Policy.

Online sexual violence and sexual harassment between children (peer-on-peer abuse)

- 17.4. St Michael's recognises that peer-on-peer abuse can take place online. Examples include the following:
 - Non-consensual sharing of sexual images and videos
 - Sexualised cyberbullying
 - Online coercion and threats
 - Unwanted sexual comments and messages on social media
 - Online sexual exploitation
 - Upskirting.
- 17.5. St Michael's responds to all concerns regarding online peer-on-peer abuse, whether or not the incident took place on St Michael's premises or using school-owned equipment.
- 17.6. Concerns regarding online peer-on-peer abuse are reported to Nicola Birch (DSL) who will investigate the matter in line with the Child Protection and Safeguarding Policy.
- 17.7. Information about St Michael's's full response to incidents of online peer-on-peer abuse can be found in the Child Protection and Safeguarding Policy.
- 17.8. Under the Voyeurism (Offences) Act 2019, it is an offence to operate equipment and to record an image beneath a person's clothing without consent and with the intention of observing, or enabling another person to observe, the victim's genitals or



buttocks (whether exposed or covered with underwear), in circumstances where their genitals, buttocks or underwear would not otherwise be visible, for a specified purpose.

- 17.9. A "specified purpose" is namely:
 - Obtaining sexual gratification (either for themselves or for the person they are enabling to view the victim's genitals, buttocks or underwear).
 - To humiliate, distress or alarm the victim.
- 17.10. "Operating equipment" includes enabling, or securing, activation by another person without that person's knowledge, e.g. a motion activated camera.
- 17.11. Upskirting is not tolerated by St Michael's.
- 17.12.Incidents of upskirting are reported to Nicola Birch (DSL) who will then decide on the next steps to take, which may include police involvement, in line with the Child Protection and Safeguarding Policy.

Sexting and the sharing of indecent imagery of pupils

- 17.13. Sharing indecent imagery is the sending or posting of sexually suggestive images of under-18s via mobile phones or over the internet. Creating and sharing sexual photos and videos of individuals under 18 is illegal.
- 17.14.[New] Staff will receive appropriate training regarding child sexual development and will understand the difference between sexual behaviour that is considered normal and developmentally expected, and sexual behaviour that is inappropriate and/or harmful.
- 17.15.All concerns regarding sexting are reported to Nicola Birch (DSL).
- 17.16.[New] Nicola Birch (DSL) will use their professional judgement, in line with the Child Protection and Safeguarding Policy, to determine whether the incident is experimental, i.e. expected for the developmental stage of the pupils involved, or aggravated, i.e. involves additional or abusive elements, the images are used recklessly or there is an intent to harm the pupil depicted.
- 17.17.[New] Where the incident is categorised as 'experimental', the pupils involved are supported to understand the implications of sharing indecent imagery and to move forward from the incident.
- 17.18.[Updated] Where there is reason to believe the incident will cause harm to the pupil depicted, or where the incident is classified as 'aggravated', the following process is followed:
 - Nicola Birch (DSL) holds an initial review meeting with appropriate school staff
 - Subsequent interviews are held with the pupils involved, if appropriate
 - Parents are informed at an early stage and involved in the process unless there is a good reason to believe that involving the parents would put the pupil at risk of harm
 - At any point in the process if there is a concern a pupil has been harmed or is at risk of harm, a referral will be made to children's social care services and/or the police immediately



- The interviews with staff, pupils and their parents are used to inform the action to be taken and the support to be implemented
- 17.19. When investigating a report, staff members will not view and nude and semi-nude images unless there is a good and clear reason to do so.
- 17.20.If a staff member believes there is a good reason to view nude or semi-nude imagery as part of an investigation, they discuss this with Nicola Birch (DSL) and Alyson Rigby first.
- 17.21. The decision to view imagery is based on the professional judgement of Nicola Birch (DSL) and always complies with the Child Protection and Safeguarding Policy.
- 17.22.[New] If a decision is made to view the imagery, Nicola Birch (DSL) will be satisfied that viewing:
 - Is the only way to make a decision about whether to involve other agencies because it is not possible to establish the facts from any pupil involved.
 - Is necessary in order to report the image to a website or suitable reporting agency to have the image taken down, or to support the pupil in taking down the image or in making a report.
 - Is unavoidable because a pupil has presented it directly to a staff member or nudes or semi-nudes have been found on an education setting's device or network.
- 17.23.[New] Where it is necessary to view the imagery Nicola Birch (DSL) will:
 - Never copy, print, share, store or save images; this is illegal.
 - Discuss the decision with Alyson Rigby.
 - Undertake the viewing themselves, or make sure viewing is undertaken by another member of the safeguarding team with delegated authority from Alyson Rigby.
 - Make sure viewing takes place with Alyson Rigby or another member of the <u>SLT</u> in the room; additional people in the room will not view the imagery.
 - Only view the imagery on St Michael's premises.
 - Record how and why the decision was made to view the imagery in line with the <u>Record Management Policy</u> and the <u>Child Protection and</u> <u>Safeguarding Policy</u>.
 - Make sure that images are viewed by a member of staff of the same sex as the pupil, where appropriate.
 - Ensure that, if devices need to be passed on to the police, the device is confiscated, disconnected from Wi-Fi and data and turned off immediately to avoid imagery being accessed remotely; the device will be secured until it can be collected by police.
- 17.24.[New] Imagery will not be purposefully viewed where it will cause significant harm or distress to any pupil involved, in line with Nicola Birch's professional judgement.
- 17.25. Any accidental or intentional viewing of imagery that is undertaken as part of an investigation is recorded.
- 17.26.[New] Where a staff member has accidentally viewed a nude or semi-nude image, Nicola Birch (DSL) will ensure they are provided with the appropriate support, as viewing nude or semi-nude imagery of pupils can be distressing.



17.27. Viewing and deleting imagery is carried out in line with the <u>Searching</u>, <u>Screening</u> and <u>Confiscation Policy</u>.

Online abuse and exploitation

- 17.28. Through the online safety curriculum, pupils are taught about how to recognise online abuse and where they can go for support if they experience it.
- 17.29.St Michael's responds to concerns regarding online abuse and exploitation, whether or not it took place on St Michael's premises or using school-owned equipment.
- 17.30.All concerns relating to online abuse and exploitation, including child sexual abuse and exploitation and criminal exploitation, are reported to Nicola Birch (DSL) and dealt with in line with the Child Protection and Safeguarding Policy.

Online hate

- 17.31.St Michael's does not tolerate online hate content directed towards or posted by members of St Michael's community.
- 17.32.Incidents of online hate are dealt with in line with the relevant school policy depending on the nature of the incident and those involved, e.g. Staff Code of Conduct.

 Conduct, Anti-Bullying Policy and Adult Code of Conduct.

Online radicalisation and extremism

- 17.33.St Michael's's filtering system protects pupils and staff from viewing extremist content.
- 17.34.Concerns regarding a staff member or pupil being radicalised online are dealt with in line with the Child Protection and Safeguarding Policy and Prevent Duty Policy.

18. Remote learning

- 18.1. All remote learning is delivered in line with St Michael's's Pupil Remote Learning
 Policy.
- 18.2. All online Home Learning will be conducted via Google Services, this means that every communication will be monitored by Alyson Rigby and members of SLT.
- 18.3. All staff and pupils using video communication must:
 - Communicate in groups one-to-one sessions are only carried out where necessary.
 - Wear suitable clothing this includes others in their household.
 - Be situated in a suitable 'public' living area within the home with an appropriate background 'private' living areas within the home, such as bedrooms, are not permitted during video communication.
 - Use appropriate language this includes others in their household.
 - Maintain the standard of behaviour expected in school.
 - Use the necessary equipment and computer programs as intended.
 - Not record, store, or distribute video material without permission.
 - Ensure they have a stable connection to avoid disruption to lessons.



- Always remain aware that they are visible.
- 18.4.St Michael's will consider whether one-to-one sessions are appropriate in some circumstances, e.g. to provide support for pupils with SEND. This will be decided and approved by the <u>SLT</u>, in collaboration with <u>Michelle Higgins</u>.
- 18.5. Pupils not using devices or software as intended will be disciplined in line with the **Behavioural Policy**.
- 18.6.St Michael's will risk assess the technology used for remote learning prior to use and ensure that there are no privacy issues or scope for inappropriate use.
- 18.7. If possible, St Michael's will consult with parents at least two weeks prior to the period of remote learning about what methods of delivering remote teaching are most suitable alternate arrangements will be made where necessary. If a bubble is required to isolate, this two week period can be ignored in order to quickly facilitate access to home learning.
- 18.8.St Michael's will ensure that all school-owned equipment and technology used for remote learning has suitable anti-virus software installed, can establish secure connections, can recover lost work, and allows for audio and visual material to be recorded or downloaded, where required. Google Accounts will be used for this.
- 18.9.St Michael's will communicate to parents in writing about any precautionary measures that need to be put in place if their child is learning remotely using their own/family-owned equipment and technology, e.g. ensuring that their internet connection is secure.
- 18.10. During the period of remote learning, St Michael's will maintain regular contact with parents to:
 - Reinforce the importance of children staying safe online.
 - Ensure parents are aware of what their children are being asked to do, e.g. sites they have been asked to use and staff they will interact with.
 - Encourage them to set age-appropriate parental controls on devices and internet filters to block malicious websites.
 - Direct parents to useful resources to help them keep their children safe online.
- 18.11.For children without internet access at home, St Michael's will provide internet access with Wifi Dongle.
- 18.12.For children with internet access at home, St Michael's will not be responsible for providing access to the internet off St Michael's premises and will not be responsible for providing online safety software, e.g. anti-virus software, on devices not owned by St Michael's.

19. Monitoring and review

- 19.1. St Michael's recognises that the online world is constantly changing; therefore, Nicola Birch (DSL), MGL and Tom Ferry and Alyson Rigby conduct half-termly light-touch reviews of this policy to evaluate its effectiveness.
- 19.2. The <u>governing board</u>, <u>Alyson Rigby</u> and DSL review this policy in full on an <u>annual</u> basis and following any online safety incidents.



19.3. The next scheduled review date for this policy is <u>July 2022</u>.

Any changes made to this policy are communicated to all members of St Michael's community.
